## Biographical Sketch:

Distinguished experience of more than 40 years, as clinician, researcher, teacher, policy matters and in public health administration. The significant achievements are as under:

- Instrumental in the establishment of 75 new Ayush clinics in the conventional primary health care dispensaries. The objective was Universal Health Coverage of high quality in Delhi.
- Provided supportive supervision as Principal Investigator/Co-PI to 30 clinical, 22 fundamental, 40 verification, 20 drug proving studies and 3 public health programs.
- 10 MoUs with different organizations in USA, UK, Mexico, Argentina, Canada, Armenia, Australia, Brazil, Germany, and Israel were signed for creating a network for International multicentric studies.
- Short-Term Studentship in Homoeopathy (STSH) program and MD scholarship program were instituted for inculcating research aptitude among students at Homoeopathic colleges. 30 MOUs were signed with colleges for handholding in research.

- As Chairman of sub-committee of Drug Technical Advisory Board, of Government of India, brought amendments in the rules of Drug and cosmetic Act for popularizing and ensuring wide availability of homoeopathic drugs.
  - As Director (AYUSH) spearheaded several initiatives of Government in providing integrative care to COVID-19 patients using AYUSH systems beside undertaking 5 clinical research projects on data collection.
